

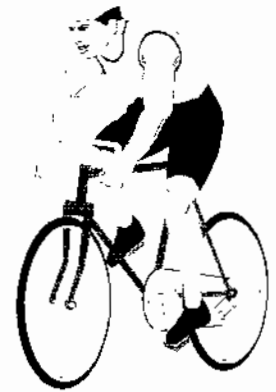


11th Annual TOUR de PETS

Your registration fee provides you with sag support, map, manned rest stops with refreshment, Event T-shirt (pre-registration only), access to city park swimming pool, a meal post ride, AND a chance at \$300.00 in "door" prizes!!

We hope the spring season has been a good training time for you, and that you'll come test your skills on our ride this year. These are great routes in that they offer three levels of difficulty as well as four distances to ride or further train. We've added a century route this year which will be an extension of our metric course. This is great terrain for training, and we promise to take exceptional care of you as you enjoy the day with us. We go to great lengths to make sure that our participants are safe from the beginning to the end. Bring your camping chair so that afterward you can sit in the shade of the oak trees and enjoy the post-ride meal while planning your next ride!

Proceeds from this ride benefit AWA, a non-profit, all volunteer animal welfare organization. We formed in 2000, and over the past six years due to the success of our fund raisers and the loyalty of our contributors and volunteers, we have been able to offer thousands of dollars in assistance to needy pet owners for spays, neuters, and emergency veterinary care, as well as low-cost rabies clinics. These are programs that we will continue to develop, but we also have goals of instituting education and pet therapy programs, as well as hiring a trained animal cruelty investigator. Tour de Pets is our biggest fund raiser, so we thank you for your participation, as it helps us further our goals. We hope you have a GREAT ride!

Start/Finish and REGISTRATION will be in the same location as in 2006...the Shelby City Park, 901 West Sumter Street just across the street from the library. Directions to the park: Take NC Hwy 74 to Shelby. If traveling west, take a right onto Business 74 (at Exxon, Hampton Inn, and Cleveland Mall). This is Marion Street. Follow it about five miles to the old Court Square and Lafayette Street. Take a right onto Lafayette. Go one block and turn left onto Sumter Street. Shelby City Park will be about one mile away on the right. If traveling east, after the intersection of NC Hwy 74 and NC 226 (CVS and Ingles on the left), cross First Broad River and take the first left (look for Tour-de-Pets sign on roadside). Go about a mile and a half, turn left onto Howie Drive at the library. The City Park is straight ahead!
